### Universal Declaration of Human Rights

The Declaration was proclaimed by the United Nations General Assembly in Paris

on 10 December 1948 (General Assembly resolution 217 A) as a common standard of achievements for all peoples and all nations.

### **ARTICLE 2.**

Everyone is entitled to all the rights and freedoms set forth in this Declaration, without distinction of any kind, such as race, colour, sex, language, religion, political or other opinion, national or social origin, property, birth or other status. Furthermore, no distinction shall be made on the basis of the political, jurisdictional or international status of the country or territory to which a person belongs, whether it be independent, trust, non-self-governing or under any other limitation of sovereignty.





# What are my Human Rights?



### Nunavut's Human Rights Act says that no one should be treated differently because of:

- race
- colour
- ancestry
- ethnic origin
- citizenship
- place of origin (where you're from)
- creed
- religion
- age
- disability
  (including mental
  or physical, and
  a dependency on
  alcohol or drugs)

- gender identity and gender expression
- sexual orientation
- whether you are married or single
- family status
- pregnancy
- source of income (as long as it's not illegal)
- a criminal conviction, if you've received a pardon

Even if they did not mean to treat you differently, or if they treated you differently by accident, it is still against the law.
