

FOUNDATIONS OF NCJ CIVIL PROCEDURE LUNCH AND LEARN SERIES

The series will run on Fridays from June 16th to June 30th, 2023.

Members are invited to join Clare Cudmore, Executive Legal Officer Court Administration with the Nunavut Court of Justice for a series of Lunch and Learns for new and junior lawyers on the technical civil procedure requirements in the NCJ.

These lunch and learns are aimed at assisting lawyers with gaining a general understanding of the technical requirements in the NCJ Rules of Court and how to prepare documents that comply with the requirements of form and procedure within the NCJ Rules. These are not intended to be a comprehensive course substantive civil procedure but rather aim to help increase lawyer's general level of comfort with the basics of NCJ civil procedure and forms. Please note, this course will not focus on preparing content for pleadings or advocacy.

These lunch and learns focus primarily on the requirements of the NCJ Civil Rules of Court but lawyers practicing primarily in family or probate may find the tips and general considerations in this course helpful given the application of the general rules to specialized practice.

While these lunch and learns are geared towards those who are new to civil practice, they would also be a good refresher for lawyers practicing in Nunavut and all are welcome to register and join. Lawyers can register by click the individual links for each session.

June 16th, 2023 - Lunch & Learn – Back to Basics - reviewing & discussing the foundational Rules relating starting a civil action in the NCJ.

This lunch and learn is designed to help new and junior lawyers (or lawyers who would like a refresher on NCJ civil practice) how to navigate preparing the form (not content) of NCJ court forms when starting an action in Nunavut.

This lunch and learn will review the foundational rules and forms required to start and defend a civil action in Nunavut including reviewing the NCJ forms for originating notices, back sheet, style of cause, etc.

The session will focus on Forms 1, 2, 3, 4, and 8. Lawyers wishing to attend may wish to review the Rules associated with the referenced forms and Parts 8 and 57 of the NCJ Rules.

June 23rd, 2023 - Lunch & Learn – Reviewing & discussing the foundations of interim and interlocutory chambers practice.

This lunch and learn is designed to help new and junior lawyers (or lawyers who would like a refresher on NCJ civil practice) how to navigate preparing NCJ forms and procedural requirements when seeking interim or interlocutory relief in Nunavut.

This lunch and learn will review the foundational requirements and forms for filing a notice of motion (Form 25) and an affidavit, exhibits, and memorandums of authority in the NCJ. Lawyers attending may wish to review the rules associated with the referenced forms, and Parts 30 & 31 of the NCJ Rules.

June 30th, 2023 - Lunch & Learn – Reviewing the discussing the foundations of civil trial practice in the NCJ.

This lunch is designed to help new and junior lawyers (or lawyers who would like a refresher on NCJ civil practice) how to navigate preparing NCJ forms and procedural requirements when seeking to set a civil matter for trial in Nunavut. This lunch and learn will review the foundational requirements and forms for setting a matter for trial in the NCJ including Form 18 and Part 25 of the NCJ Rules.
