

Joanna Awa — Host Public Awareness Campaign Launch in Iqaluit

Good day and on behalf of the Law Society of Nunavut and Pauktuutit Inuit Women of Canada, welcome to the official launch of the Access to Justice for Family Violence Prevention Public Awareness Campaign.

For those of you who don't know me my name is Joanna Awa.

In the spring of 2019, Pauktuutit Inuit Women of Canada and the Law Society of Nunavut joined forces to undertake a project that would break the silence on family violence in Nunavut. The goal was to better understand the needs of Inuit women dealing with family violence and the legal barriers they face.

Though extensive research and engagement, much information was gathered from both women with lived experience and the service providers who support them. These findings and insights have informed both the Preliminary Report, including a number of recommendations which will be made public, and this Public Awareness Campaign.

Today we acknowledge the true collative spirt and the foundation of this project. From the federal and territorial governments, private, not for profit, and the many community members, we stand together to break the silence on family violence in Nunavut. I would like to welcome Rhoda Ungalaq to light the qulliq and say a prayer to remember those who have been victims of abuse and family violence, and especially to those who have lost their lives. Let us take a moment to remember.

Addressing the issue of abuse and family violence involves many organizations throughout Nunavut. One of the critical, front line organizations outside the Government of Nunavut is the RCMP.

I would like to welcome Chief Superintendent Amanda Jones, the Commanding Officer for the RCMP in Nunavut. She is the first female Commanding Officer for V Division; however, she will not be the last.
